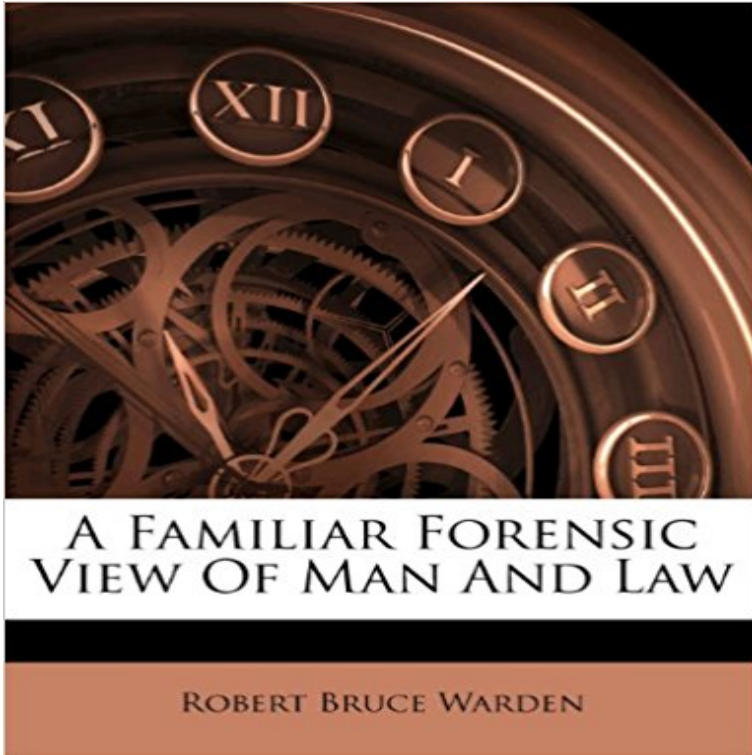


# A Familiar Forensic View Of Man And Law
