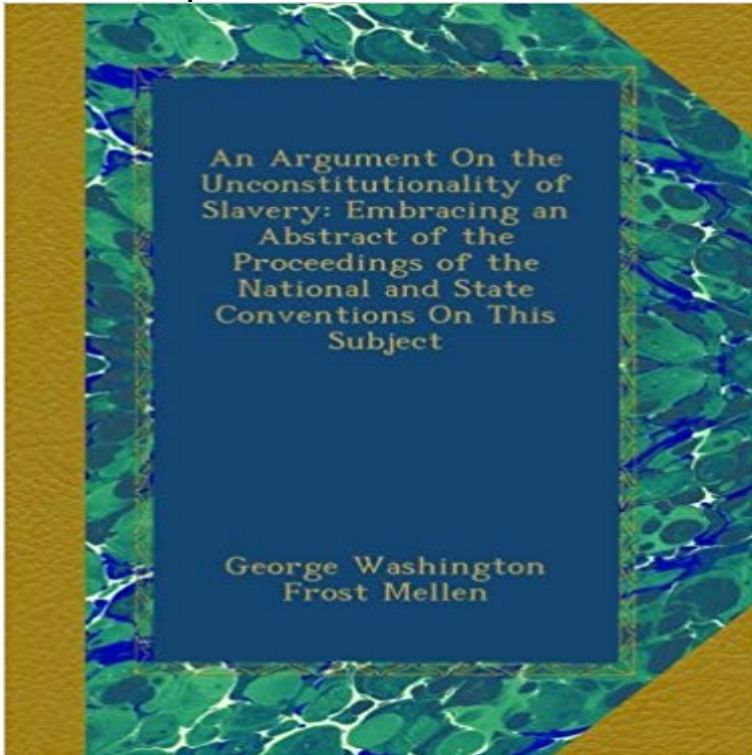


An Argument On the Unconstitutionality of Slavery: Embracing an Abstract of the Proceedings of the National and State Conventions On This Subject
