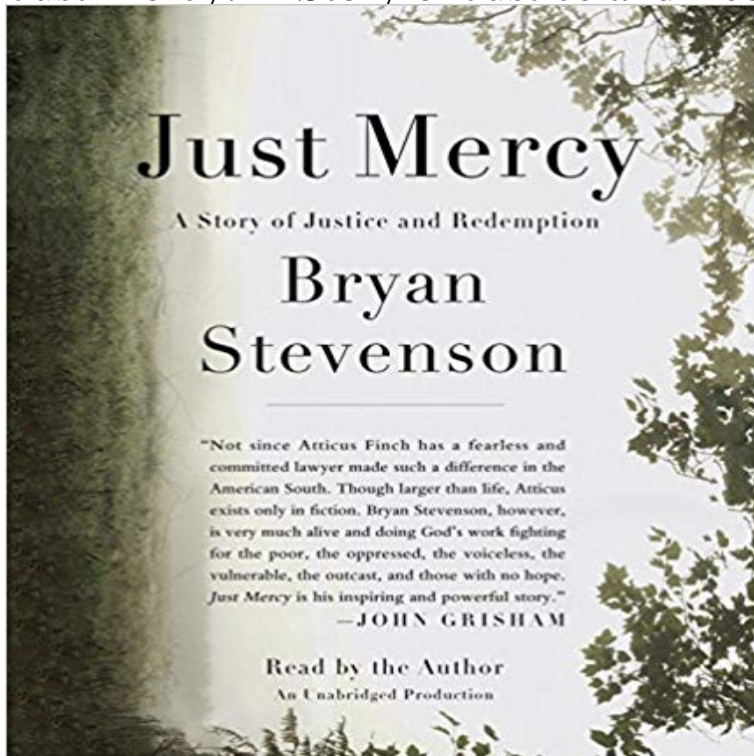


## Just Mercy: A Story of Justice and Redemption
