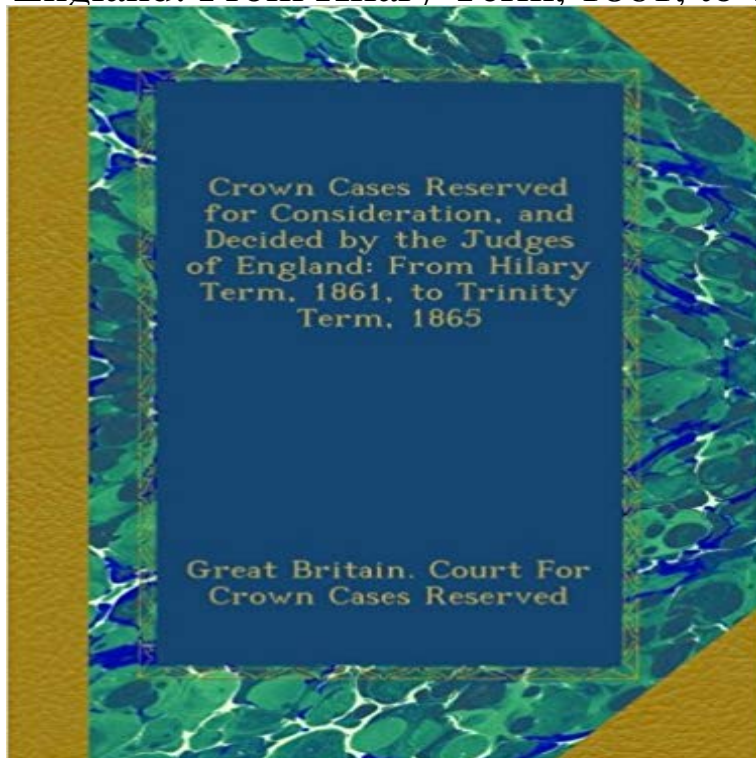


Crown Cases Reserved for Consideration, and Decided by the Judges of England: From Hilary Term, 1861, to Trinity Term, 1865
