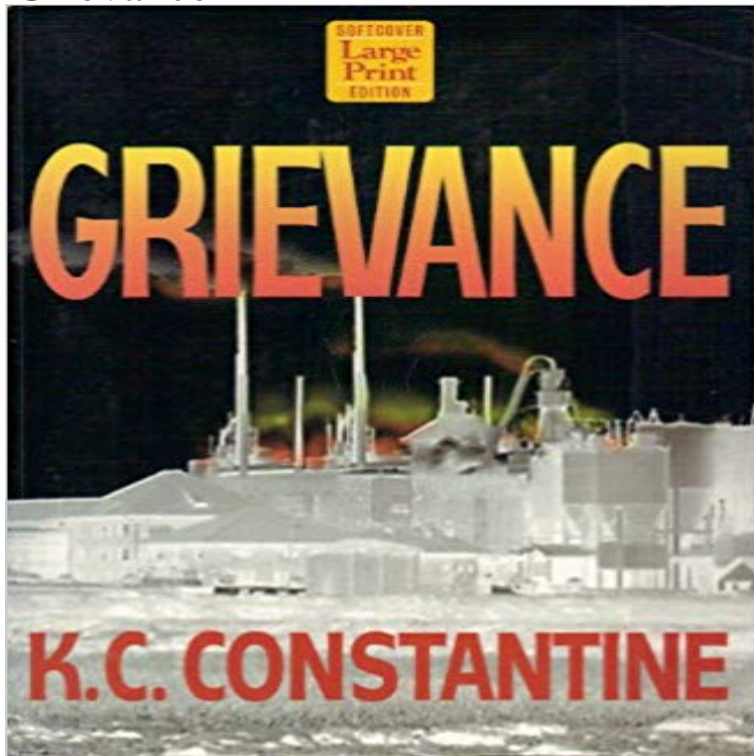


Grievance
