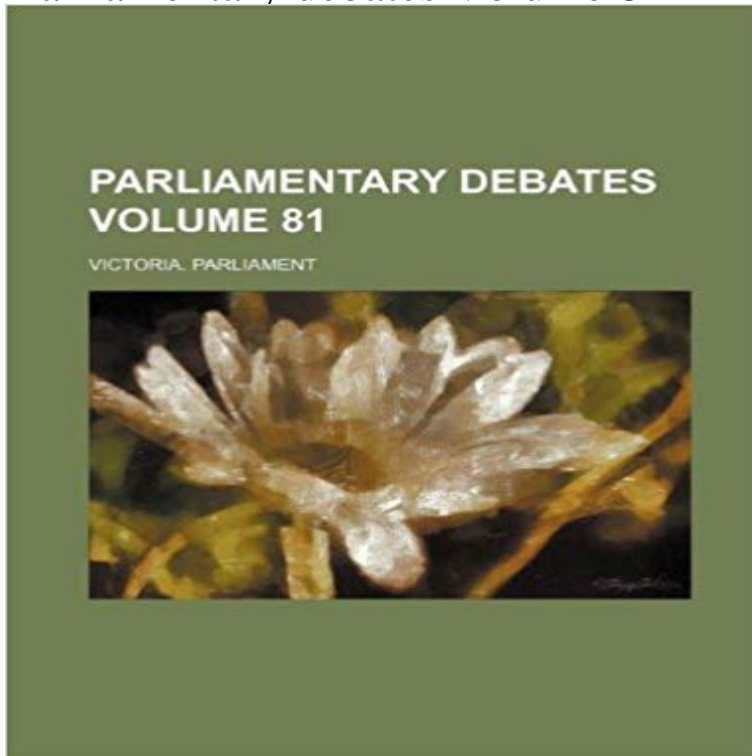

Well, it would be time enough to puss the Bill on Tuesday next. The Government would not expedite its enactment by bringing it on the following day. (Mr. I. A. Isaacs-- If the honorable member will see me after the House rises, I will try to put his views into the shape of a new clause or clauses.) But he (Mr. Murray) would not be present the following day to move them. He trusted that the Attorney-General would promise to give his attention to the matter. Mr. HAMILTON said he hoped that the Bill would not be proceeded with on the following day, because a number of country members would be away. Personally he did not like the measure at all, and he was aware that a large number of honorable members did not like it. He considered that the last clause, which brought in entirely new matter, was highly

undesirable. He would ask that the further consideration of the Bill might be p...
