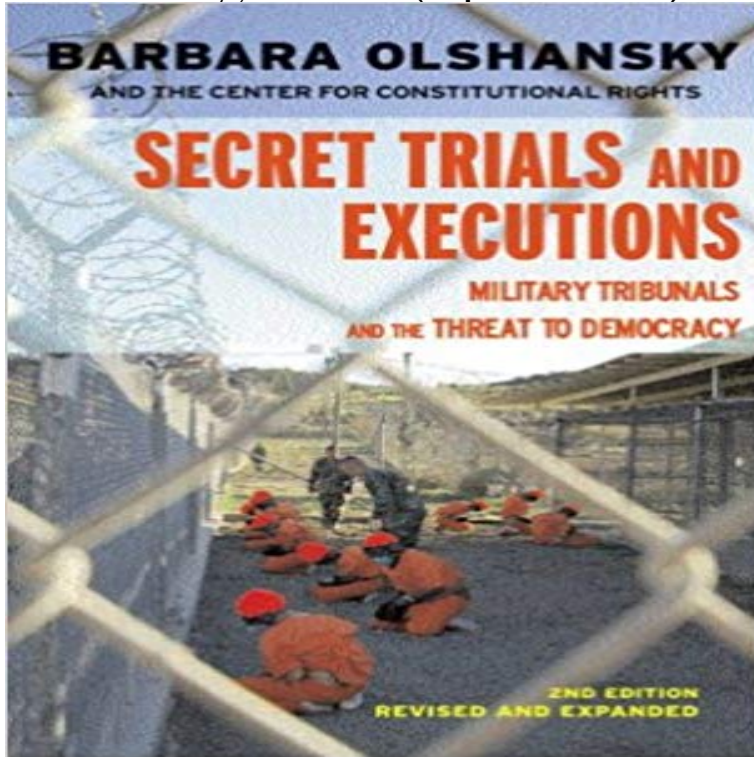


## Secret Trials and Executions: Military Tribunals and the Threat to Democracy, 2nd ed. (Open Media)
