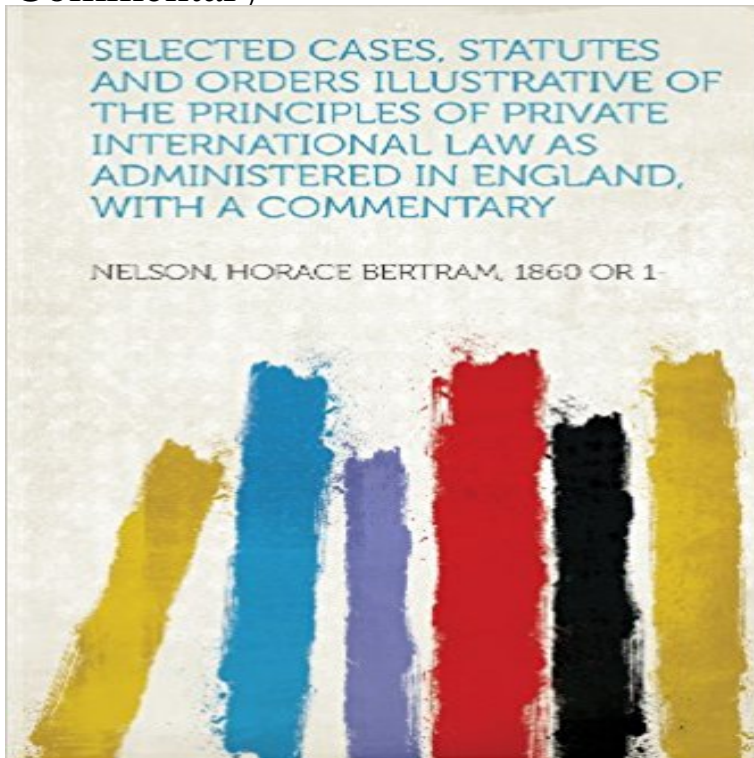


Selected Cases, Statutes and Orders Illustrative of the Principles of Private International Law as Administered in England, With a Commentary
