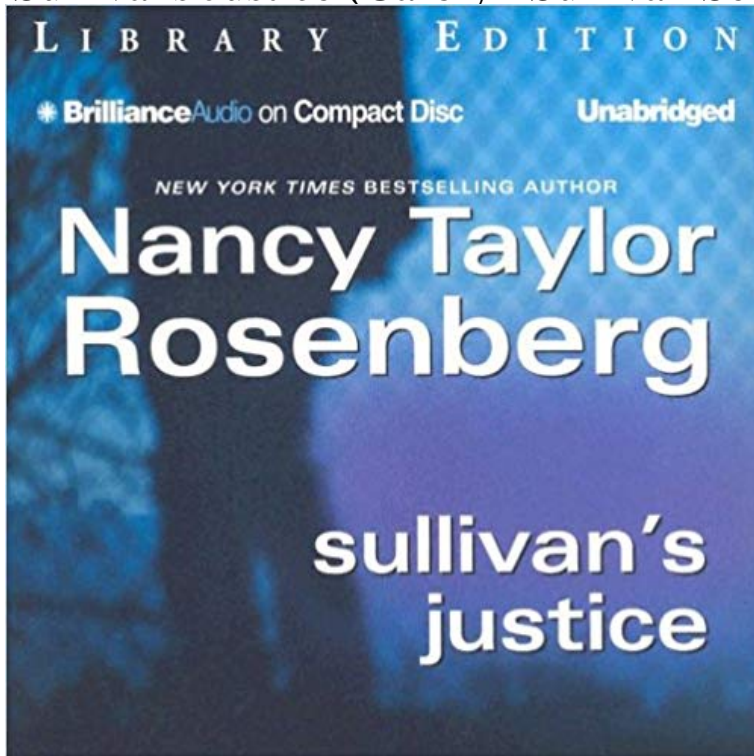


## Sullivans Justice (Carolyn Sullivan Series)
