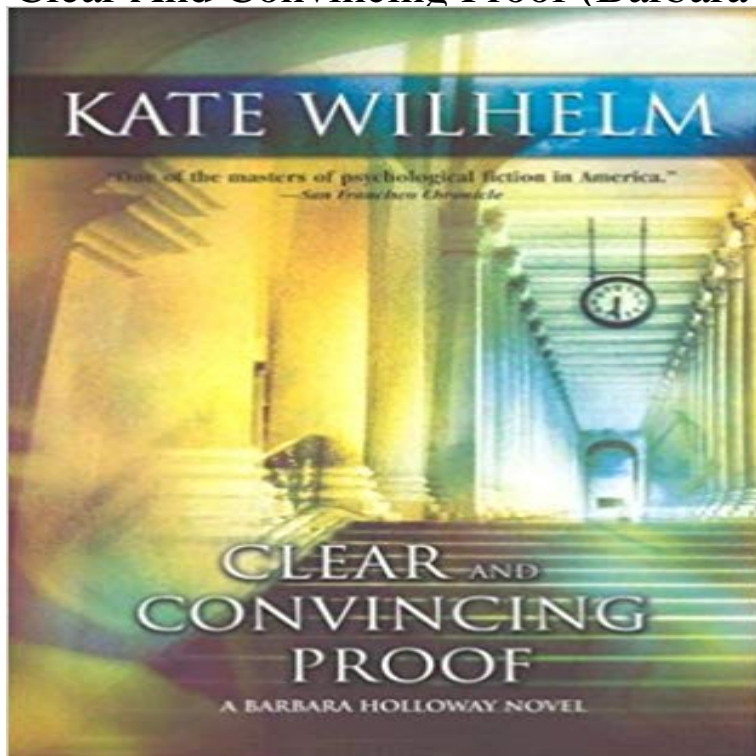


## Clear And Convincing Proof (Barbara Holloway Novels)
